Grants Support Expanded, Enhanced Summer Programming for Local Kids

Community Foundation grants are helping local kids recover academically and emotionally from the impacts of COVID-19 through summer programming.

The past year has been hard on all of us, but there's extra reason to be concerned about the impact of the COVID-19 crisis on children. As many schools switched to virtual learning platforms because of safety concerns, a significant number of students struggled to keep up due to slow, inconsistent Wi-Fi access. Children who were already at risk for food insecurity were left without regular access to subsidized school meals. And the pandemic dramatically increased the number of young people suffering from depression, anxiety, and other mental health challenges.

As we begin to see our community's

infection rates go down, many local social service organizations have plans to help students regain lost ground this summer. About half of the \$305,000 in Special Project Grants that the Community Foundation awarded during our spring grants cycle will support enhanced and expanded summer programming for St. Joseph County children.

The past year has been hard on all of us, but there's extra reason to be concerned about the impact of the COVID-19 crisis on children.

BOYS & GIRLS CLUBS A \$100,000 Special Project grant will support the Boys & Girls Clubs of St. Joseph County's "No Screen" summer programming in multiple Clubs in South Bend and Mishawaka, reaching more than 500 students.

"We've asked a lot of kids this year, and I continue to be impressed by the resilience and positivity they've shown," says Jacqueline Kronk, CEO of the Clubs. "Now we want to give kids a chance to be kids."

"No Screen" summer programming gets kids off their devices and outside as much as possible, with sports, games, visual and performing arts, science projects, and yoga. Children who participate will receive free breakfast and lunch daily.

FIVE STAR LIFE A nonprofit that incorporates a social and emotional learning curriculum in its work with at-risk children, Five Star Life will use a \$30,000 Special Project grant to enroll more St. Joseph County students from kindergarten through 12th grade in its summer programs at Summit, its 300-acre camp in Union, MI. At Summit, students get to participate in archery and hatchet throwing, nature education, sports, horseback riding, team-building, and leadership development.

ROBINSON COMMUNITY LEARNING CENTER The Robinson Community Learning Center (RCLC) will use a \$20,000 Special Project grant to scale up its existing summer programming. The RCLC will increase the ages of children that it serves, incorporating preschoolers for the first time. It will also extend its weeks of operation, and offer morning and afternoon sessions. RCLC staff will work with children to address learning loss in reading and math, and will include the "Take Ten" curriculum, which focuses on teaching children skills to handle conflict in a peaceful way.

We're glad that our Special Project grant funding will help hundreds of local children begin to recover from the challenges and losses of the past year as they enjoy the kind of fun, learning-filled summers they deserve.

21st Century Scholar Success Initiative Update

The pandemic has had a crushing effect on higher education: Fewer students are completing the FAFSA, and college and university enrollment numbers are down. That's why we and our 40+ partners are working to ensure that eligible St. Joseph County students enroll in and successfully complete the 21st Century Scholars program, which provides free tuition to any Indiana college or university.

With the support of a generous \$4.1 million grant provided by Lilly Endowment Inc., we've begun putting a number of building blocks in place that will help, including the following: • A new Quick Start Competitive Grant program which awards grants of up to \$2,500 to St. Joseph County middle schools, high schools, and other nonprofit youthserving organizations to support new, creative efforts to enroll and retain 21st Century Scholars.

• New 21st Century Success Fellowships which provide \$5,000 stipends to current 21st Century Scholars—high school seniors or college students who reside in St. Joseph County and are enrolled in a St. Joseph County-based school—to participate in a program aimed at personal leadership development, career preparation, and degree completion.

• Financial support for **additional staff capacity** at IUSB and Ivy Tech South Bend, allowing these schools to provide increased supports and services to college Scholars as they complete their degrees.

Together with our partners, we're committed to dramatically increasing 21st Century Scholar enrollment and completion in St. Joseph County.

Own an IRA? RMDs Are Back for 2021

RMDs are back for 2021—and while these mandatory annual withdrawals are an irritant for many IRA owners, they present an efficient, effective opportunity for charitable giving.

When IRA owners reach age 72, they must begin taking an annual withdrawal from their IRA, known as the required minimum distribution (RMD). The amount varies based on the owner's age and the IRA's balance.

IRA owners saw two COVID-related changes in 2020: The SECURE Act changed the age at which RMDs must begin from 70½ to 72, and the CARES Act waived RMDs for the year. But the RMD waiver was not renewed for 2021, which means anyone 72 or older must take their RMD by the end of the year to avoid tax penalties.

Luckily, there's a tax-savvy alternative: the IRA charitable rollover, a gift made from an IRA directly to a charity.

Luckily, there's a tax-savvy alternative: the IRA charitable rollover, a gift made from an IRA directly to a charity. The IRA charitable rollover allows IRA owners to support their favorite causes with pre-tax assets. (Some limitations apply: For example, IRA rollovers cannot be made to a donor-advised fund.) With a rollover gift, the money that goes to the charity is not subject to tax—a very efficient way to give!
