St. Joe County Library Opens Renovated Main Branch

The Library has opened the doors to its renovated and expanded Main Branch, and the view inside is absolutely stunning.

When the St. Joe County Library broke ground for its construction project on March 21, 2020, no one realized that a global pandemic was just around the corner. Through it all, the work on Wayne and Michigan kept moving forward. Now, 19 months later, the project is complete, and we're celebrating a fabulous new resource that will benefit our community for generations to come.

It's a resource that pushes the boundaries of what people expect when they think of libraries. In addition to traditional assets such as books, periodicals, and audiovisual materials, the renovated Main Branch and the new Community Learning Center provide inspiring spaces and resources for meeting, learning, creating, and gathering—a state-of-the-art tech

studio, a 250-seat auditorium, expanded and enhanced areas for children and teens, an updated Local History collection, and a beautiful civic green space, to name only a few.

The Community Foundation has worked closely with the Library administration team on this project from its inception, raising more than \$10 million to support the renovation and new construction.

"This is the single largest fundraising commitment that we've ever made to a local capital campaign," says Rose Meissner, president of the Community Foundation. "That underscores how firmly we believe that libraries are essential to creating vibrant, thriving communities."

Within the next few weeks, the Community Foundation will be moving into our new office suite on the third floor of the Community Learning Center. Just like you, we can't wait to take advantage of everything this exceptional new facility has to offer!

The first 2021 Special Recognition Award goes to **Boys & Girls Clubs** of **St. Joseph County**, whose promising new STRIVE Program builds on its strong foundations as a provider of supplemental education to address the learning loss suffered by local students during the COVID-19 crisis.

The Foundation's second 2021 Special Recognition Award goes to **St. Margaret's House**, honoring the organization's 30-year commitment to caring for women in our community with staff trained in trauma-centered care and the principles of restorative justice.

La Casa de Amistad Named 2021 Leighton Award Winner

Congratulations to La Casa de Amistad, winner of the Community Foundation's \$150,000 Leighton Award for Nonprofit Excellence.

As the region's only comprehensive bilingual center serving the Latino community, La Casa de Amistad provides more than 1,000 families with services that include programming for children from preschool through high school, a food pantry, social services and referrals, English language classes, legal support, technology training, advocacy, and more.

La Casa's talented, committed leadership team and staff have made the organization a highly trusted resource within the Latino community and beyond. Local, regional, and national organizations look to La Casa for guidance in working with the Latino community, and programs La Casa has developed, including its South Bend ID program and its onsite COVID-19 vaccination program, serve as models for others.

"The Leighton Award couldn't be more timely for us," says Juan Constantino, La Casa's executive director. "We just moved into a new center, fives times the size of our old building." In the new, 40,000 sq. ft. space on the southern edge of South Bend, La Casa has ample room to expand its services and programming.

As the 2021 Leighton Award winner, La Casa receives a \$150,000 endowment challenge grant and must raise \$150,000 in matching funds. The resulting \$300,000 will be added to La Casa's endowed fund with the Community Foundation, providing additional annual resources to support the organization's mission.

"The Leighton Award cements our community's commitment to what La Casa de Amistad does and stands for," says Constantino. "¡Gracias!"

Smart Year-End Giving Strategies

Community Foundation President Rose Meissner offers suggestions for smart, effective year-end giving.

The end of the year is a perfect time to count our blessings and give back to charities we care about. Here are a few tips to consider as you plan your philanthropic contributions for 2021.

Bunch your annual giving. Higher standard deductions (\$12,550 for single filers; \$25,100 for joint) make it harder for many taxpayers to itemize. Creating a Community Foundation donoradvised pass-through fund allows you to double up your giving this year but grant the gifts out to charities over two or more years. (Minimum donation for new donor-advised pass-through or endowed fund is \$10,000).

Provisions to promote charitable giving extended to 2021.

Single taxpayers who do not itemize deductions can deduct up to \$300 for contributions to qualifying charities (\$600 for couples). Taxpayers who do itemize may deduct cash gifts up to 100% of their 2021 adjusted gross income.

Gift appreciated stock. The stock market has had another great year. Consider gifting appreciated stock you've owned more than one year to avoid capital gains taxes. You can use the cash you would have given to charity to buy the stock back at a higher cost basis.

If you're over 70½, consider making your gifts directly from your IRA to the Community Foundation or other charities.

Gift directly from IRAs to charity.

If you're over 70½, consider making your gifts directly from your IRA to the Community Foundation or other charities. This counts toward your required minimum distribution (RMD) and you won't pay income tax on the amount transferred. (*Donor-advised funds are excluded*).

Stretch the value of your gift with matching opportunities. Gifts to the La Casa de Amistad Fund and the 21st Century Success Fellowship Fund will be matched (*see sidebar*).
